Customer agrees to release and waive the City from all damages to Customer's property caused by the City in the normal course of its duties to collect refuse from the Customer or from further incidental damage to the property resulting from such damage.

**In the event of a change of commercial refuse rates by ordinance or an increase in county landfill fees during this contract term,  
Customer will be billed by the City at the new rates including landfill charges.**
